Sub: Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Suspension of operations due to flooding and heavy rains at the Sahapuram Plant of the Company

Pursuant to Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we would like to inform you that the operations at the Company's plant located at Arumuganeri P.O., Sahapuram, Tamil Nadu have been temporarily suspended owing to flooding and water logging at the factory premises caused by heavy rains since Sunday, December 17, 2023.

While the rain has receded, the water logging is expected to continue for few more days due to release of water from the adjacent dam. The Company expects gradual scale up of operations after the water levels get back to normal and anticipates at least 7 days to get back/resume its usual business operations.

The Company is taking adequate measures to ensure safety of equipments, materials and all personnel.

We would keep the Stock Exchanges and all our stakeholders updated on any significant developments going forward and shall also keep informed as soon as the plant becomes operational.

Further in terms of SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 read with Regulation 30 Para B of Part A of Schedule III of the Listing Regulations, the additional information required is given in the Annexure - A.
